From successfully hosting the Bondi Open as a PSA event to fostering the growth of our junior programs and enhancing the Club's operations, Jess has been at the forefront of our club's success. I'm pleased to confirm that Jess has also assumed the role of Bondi Waverley Squash Club Secretary.

Property Updates

This year there has again been some property activity around the Club's location at 8 Denison Street spurred by various developers. The Board engaged Augusta Advisors to assist in understanding any potential benefit that the Club could capitalise on through these sales processes.

The discussions that the Board has had over the last few months, did not meet the basic requirements as approved by Members.

The engagement with Augusta demonstrated that there are significant commercial barriers to redeveloping the Club, including constructions costs, development limitations of the current site and the cost of maintaining continuity of services to members during any transition period.

Therefore, at this stage we have ceased all further discussions and the Board is now focused on improving the current site for the benefit of Members.

We are excited to confirm we have engaged a designer and are looking forward to sharing concepts and updates with you along the way.

A Promising Year Ahead for Bondi Squash.

General Management

Jess Rogerson General Manager



I'd like to start by saying a big thank you to all our members for their continued support and dedication in 2023, without which our Club cannot grow and thrive. We are so lucky to have been able to build a strong community of friendly, squash loving enthusiasts and look forward to continuing this momentum and energy into 2024.

A major focus point for the year was ensuring I had a good understanding of the Club's backend processes and refining some of our internal operations to ensure we have a strong foundation as we grow the Club in 2024. Initiatives included a review and change of our bookkeeping services, developing training manuals for myself, staff, and directors, and a transition to a new EFT service provider. These adjustments have strengthened our financial controls, improved our reporting, and streamlined operational efficiency. A significant challenge faced by the Club in 2023 was finding a sustainable long-term solution for our in-house food offerings. While temporary measures are in place, we have strategic plans for 2024 to implement a permanent solution as part of our broader goals.

One of our goals for this year was continuing to grow our membership and participation especially in our Juniors. In 2022 we started our first Juniors Squads with just 3 or 4 kids. 2023 saw a jump in Junior participation and retention with almost 10 kids coming along every week to our Junior Squads. Thank you to Anna for running these classes each week and providing a fun environment for participants to develop their skills and passion for Squash. While we still have a long way to go it's a very positive step in the right direction. We also made some changes to our adult squads with the addition of a new Advanced Squad and splitting the intermediate group into a Lower and Upper Intermediate Squads. This allowed us to provide two extra Intermediate squads a week and ensure a better training experience for players at all levels. Thank you Nick for your contribution in these changes and promotion of the new training schedule.

2023 was the first year we have hosted the Bondi Open as a PSA event, attracting a very high standard of both local and International athletes. This marked phase two of our strategic plan to elevate our club and bring more awareness to Squash in Bondi and greater Sydney. While there was a financial investment associated with hosting an international event we are excited to continue to be a leading Club in Sydney and NSW for Squash. This event, along with the additional social events such as trivia nights and Squastoberfest significantly contributed to a more vibrant and engaging club atmosphere. Bondi Squash Club continues to thrive as a vibrant and strong club in Sydney. The dedication of our members, the hard work of our staff and coaches, and the support of our directors have been instrumental in the success of the Club. As we look ahead, we remain committed to fostering a welcoming environment, striving for squash excellence and supporting squash in the greater community.

Finance

Anton Clowes Finance Sub Committee Chair



We finished the 2023 financial year with cash on hand of \$359k (up \$85k or 31%) from \$274k as at 30 September 2022, well above the \$100k minimum cash holdings required as part of the Board's financial risk management framework.

Total trading income for the year was lower than budget, and approximately 10% lower than last financial year. The reduced income compared to last financial year is principally because of the termination of the SCG arrangement in September 2022. And the reduced income compared to the 2023 budget was driven by not being able to replace the Best of Land food offering through this financial year.

Encouragingly the gross profit margin was healthy at approximately 70%, beating budget forecasts by 6 percentage points.

The financial year has seen a small increase in bar revenue and squash revenue compared to last year. Excluding the Sydney Cricket Ground Trust revenue last year, total trading income is up almost 7% on FY22.

Cash operating expenses in the 2023 financial year were well controlled (4% lower than budget and 23% lower than last financial year). Positively repairs and maintenance in the 2023 financial year were 76% lower than last year. Broadly costs are in line with budget but there is already pressure building for next financial year. As you can all imagine we are seeing supply chain impacts as well as inflationary pressures contribute to a higher cost base.

Financially the Club is in a sound cash balance position leading into financial year 2024. The Board has been developing some exciting initiatives for the Club's future with the overarching objective of making the Club work for all members.

Property & Premises

Winnie Chong Property and Premises Sub Committee Chair



Court Refresh

It has been a few years since our courts received a cosmetic facelift, so the club decided to complete some court refresh work just before our very first PSA tournament as part of the Bondi Open. The newly refreshed courts were enjoyed by players coming from all over the world, and more importantly our members. We would like to thank all the members for cooperating with the required closure of the courts during that period.

Glass Door Trial

The trial of a glass door to Court 2 has come to fruition in September 2023 thanks to Andrew Chen from our own squash community. The glass doors greatly improved the safety aspect for the players and has been well received by members. Off the back of the positive feedback, we are now applying for council community grants for 2024 and hope to implement the glass doors to the remaining courts for members to enjoy.

Creature comforts

From the feedback of the 2023 member's survey, members have shared their view on how we can continue to improve member experiences through little creature comforts. In the upcoming year, we are making plans to install heaters at viewing level and bathrooms, exhaust fans in the women's bathroom; improving amenities for the men's bathroom; reviewing ideas to further improve the front rooms in 2024 for members to enjoy. Club Operations

Jason Taleb Club Operations Chair



Key operational priorities for the board this year were to ensure a smooth transition to the new GM and to build a more sustainable staffing model.

The Club has struggled in previous years with overreliance on the general manager to keep the Club open. The traditional operating model was to have a full-time GM with a small number of casual staff to cover approximately 55 opening hours per week. This made it very difficult for the GM to take leave and contributed to high turnover in the role. It also presented a key risk to operational continuity.

The club now operates with a part-time GM (three-quarter hours) and a larger pool of casual staff. In addition, the Club's opening time during the week was brought forward from 3pm to 1pm, providing the GM with more time to focus on managing the club. The combined impact has created a more effective management model with greater flexibility for the GM to take leave.

There has also been a significant focus on streamlining and documenting operating processes. This has resulted in improved reporting accuracy and reduced operational risk as other staff can perform critical tasks when the GM is unavailable.

Our focus for the coming year will be to enhance our food and drinks offering in conjunction with the bar refurbishment.

Competitions, tournaments and programs are core to building the club community and we were delighted to make further investment in these activities for the benefit of members.

We now offer three programs per week across four competency levels, as well as juniors programs and Friday night round robin.

In the final season of the Pennant competition, we offered a significant reduction in fees to promote increased participation.

We intend to introduce more tournaments over the coming year, with a focus on attracting players with less competition experience.

NOTES TO AND FORMING PART OF THE FINANCIAL ACCOUNTS FOR THE YEAR ENDED 30TH SEPTEMBER, 2023

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

The principal accounting policies adopted by the company are stated in order to assist in a general understanding of the financial statements. These policies have been consistently applied except as otherwise stated.

The financial statements have been drawn up in accordance with the Corporations Regulations and applicable Australian Accounting Standards.

BASIS OF ACCOUNTING:

The financial statements have been prepared on the historical cost basis and except where stated do not take into account current valuations of non-current assets.

The carrying amounts of non-current assets do not exceed the net amounts that are expected to be recovered through the cash inflows and outflows arising from continued use and subsequent disposal.

(a) Investments -

Investments are shown at cost. All interest earned is shown in the Revenue Accounts.

(b) Depreciation -

Non-Current Assets, except for Freehold Land, are depreciated at rates so as to write-off their cost over their useful lives.

(c) Maintenance and Repairs –

Maintenance, repair costs and minor renewals are charged against income as incurred.

(d) Inventories (stock on hand) -

All Inventories are valued at the lower of cost and net realisable value. Cost is calculated on invoice price on a first in first out basis.

(e) Income Tax -

No provision has been made for Federal Income Tax as none is payable

(f) Employee Entitlements –

The amounts expected to be paid to employees for their pro rata entitlement to long service, annual and sick leave have been accrued at current rates of pay. Contributions are made to an industry superannuation plan in accordance with employees' entitlements under their awards.

(g) Comparative Figures -

Comparative figures are shown as they were in the 2021/2022 accounts, except where material changes in accounting classifications have occurred during the year when they have been, where possible, restated in accordance with the change. The additional dissections and apportionment of expenditure shown in the 2022/2023 accounts is for the further information of members.

(h) Core Property -

The land and building at 8 Denison Street, Bondi Junction, NSW 2022 is classified as core property pursuant to Section 41J (2) of the Registered Club Act 1976. The club does not own any non-core property.

The Directors note that this property now has an estimated value of \$12 million. The increased value is not recorded in the Balance Sheet as it is not the Club's intention to liquidate the asset.

2. FINANCIAL REPORTING BY SEGMENTS:

The Club operates predominantly in one industry. The principal activity of the Club is that of a Licensed Club under Part 10 of the New South Wales Liquor Act. The Club operates predominantly in one geographical area, being Bondi Junction, N.S.W., Australia.

3. RELATED PARTIES:

The names of each person holding the position of director of the Bondi Waverley Squash Club Limited during the financial year are Messrs R. Kittler A.Clowes, J. Taleb and Ms S Kraemer andW. Chong. No director derived any remuneration from the Club during the course of the financial year.

4. COMPANY LIMITED BY GUARANTEE:

Bondi Waverley Squash Club Limited is a company limited by guarantee with the liability of members limited to the amount set out in the Company's Memorandum and Articles of Association.

The other information required to be shown by the Corporations Regulations is contained in the accompanying Financial Accounts and Balance Sheet.
